- ▶▶ Sana AHP: An accelerated Hydrogen Peroxide solution that is effective at low concentration due to synergistic effect with other additives.
- ▶▶ Making the product effective as hand sanitizer, surface disinfectant and air disinfectant.
- ▶▶ SanaGuard: A hand moisturizing Alcohol lotion.

Sana Pharma holds highly the importance of clinical trials and continuous testing for its products in order to provide solid evidence for their safety and efficacy.

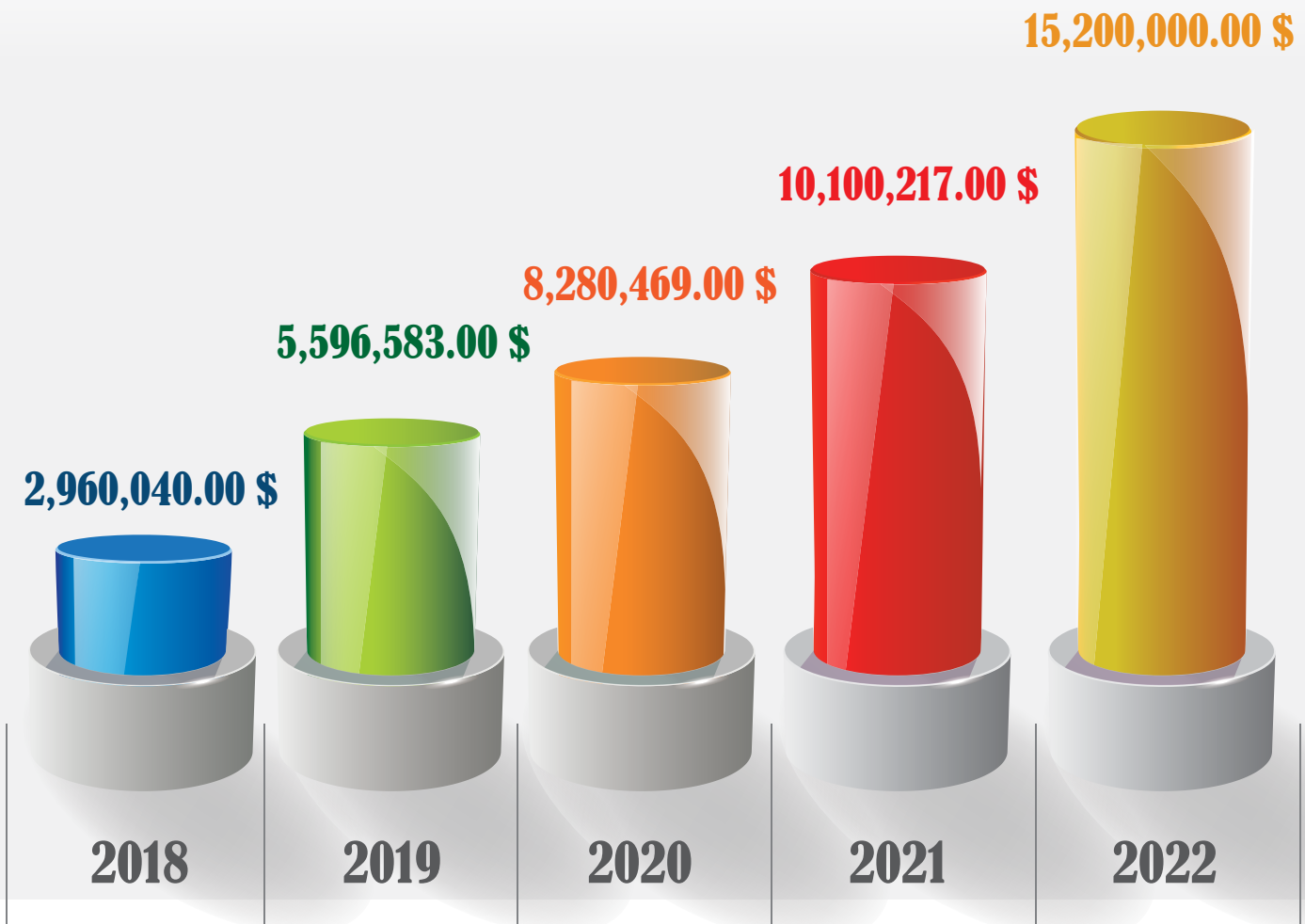
